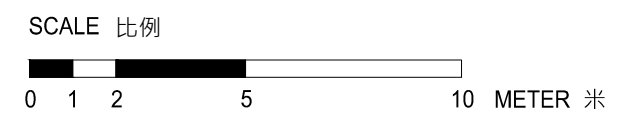
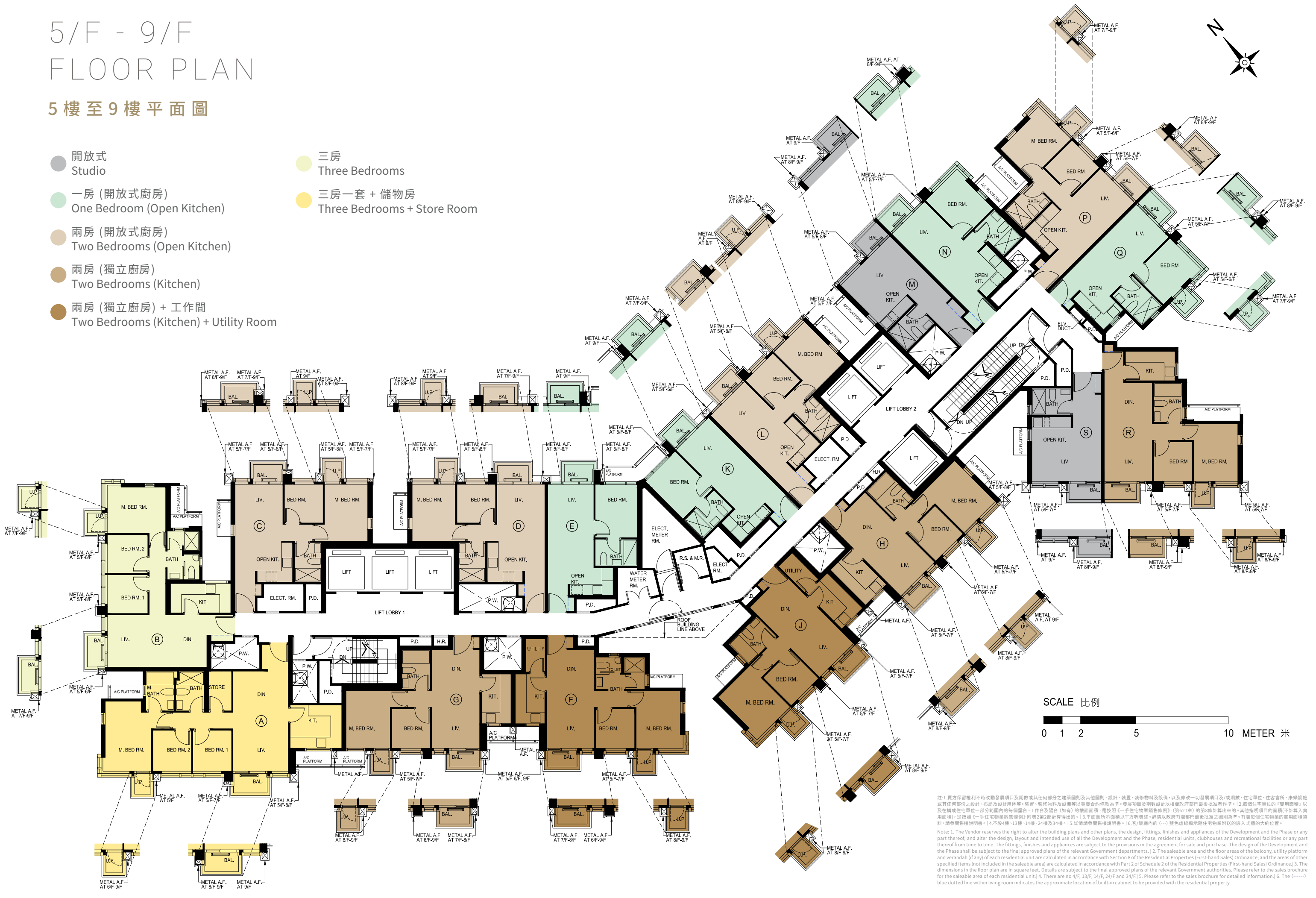


# 5/F - 9/F FLOOR PLAN
